Breed Classes

Baby Puppy	For dogs of four (4) under six (6) months of age on the first day of the show (not eligible for CC or BOB).
❖ Minor Puppy	For dogs of six (6) under nine (9) months of age on the first day of the Show.
❖ Puppy	For dogs of nine (9) under twelve (12) months of age on the first day of the Show.
❖ Junior	For dogs of twelve (12) under eighteen (18) months of age on the first day of the Show.
❖ Graduate	For dogs of eighteen (18) under twenty- four (24) months of age on the first day of the Show.
❖ Open	For dogs of any Breed therein provided for.
Champion	Officially a KUSA Champion – Does not compete for CC
SA Bred	Dogs born in South Africa
Veteran	Over 7 years of age
Neuter Dog	For dogs of any age that have been castrated for whatever reason (not eligible for CC or BOB).
Members	Exhibitor is a member of the show holding club.
Breeders	The exhibitor is the breeder
Working Dog	Minimum qualifications: Class A, CD, IPO 1, BWT or TT 2/ITT 2
Maiden	For dogs that have not won a prize at any Championship show
Novice	For dogs that have not won a first prize at any Championship show
Imported	Imported from any country outside of KUSA jurisdiction
Namibian Bred	Dogs born in Namibia
Visitors	Dogs domiciled beyond a 160 km radius of the show.
Local	Dogs domiciled within a 160 km radius of the show.
Progeny	At least 3 dogs each entered in a breed class other than Brace or Team together with sire OR dam that need NOT be entered in another class.
Brace	Two exhibits of one breed belonging to the same exhibitor, each exhibit having been entered in a breed class other than brace.
Team	Three or more exhibits of one breed belonging to the same exhibitor, each exhibit having been entered in a breed class other than brace.

Declaration by the Owner, Exhibitor or Authorised Agent

By my signature to this form, or where the form is submitted electronically, by inserting my full name and surname, I the Registered owner, exhibitor or authorised agent of the dog detailed above, affirm that I have read and understood the full contents of this entry form including the contents of this declaration.

Alternatively, by electronic submission of this form to KUSA I, the Registered owner, exhibitor or authorised agent of the dog detailed above, affirm that I have read and understood the full contents of this form including the contents of this declaration. I thereby further declare that I understand and accept that:

1. By entering, exhibiting or handling a dog at a show held under a Kennel Union licence I agree to be bound by the KUSA Constitution (as amended) in its entirety including all the schedules thereto. (hereafter "the Constitution").
2. The attendance or exhibition of a dog that has either suffered from or been exposed to any infectious or contagious disease(s) within 6 weeks prior to the show, or that is suffering from such disease(s) at the time of the show, is contrary to the Constitution. Contravention of this regulation by me may result in disciplinary action in terms of Schedule 1 Rule 2.
3. This dog is entered and exhibited entirely at my own risk. Accordingly, unless specifically authorised to the contrary by a Judge, or while the dog is in the ring or carrying out any licensed event as part of the competition, or engaged in practice prior to participating in the show, I will ensure that the dog is at all times properly secured either within a suitable container or by a lead or leash that must at all times be either hand-held or securely anchored.
4. I am fully responsible for my dog's safety and behaviour at all times to the extent that I accept personal liability in respect of any claim made in respect of any damage or injury caused by my dog and/or my failure to adequately control my dog. I acknowledge that my dog has the ability to cause harm to other dogs, persons or property at the show.
5. I indemnify KUSA, the affiliated Club conducting this Show, and the Officers of the Club against any and all claims of whatsoever nature and howsoever arising that may be levelled against them, jointly or severally, in respect of any harm caused by my dog and/or any failure on my part to adequately control my dog.
6. I am fully responsible and liable for any harm caused to any person, animal or property arising out of any action by any minor child for whom I am legally responsible by allowing them to handle a dog for which I am responsible.
7. I indemnify KUSA, the affiliated Club conducting this show, and the Officers of the Club, against any and all claims of whatsoever nature and howsoever arising that may be levelled against them, jointly or severally, in respect of any harm caused by any minor child for whom I am legally responsible at the show.
8. I confirm that my entry forms and documentation are complete, and that the contents thereof are true and correct and entirely free of any false or inaccurate information.
9. Where any information in my entry forms and documentation is inaccurate to any degree whatsoever, I may be subject to disciplinary action in terms of schedule 1 Rule 2, and that any awards and/or prizes may be withdrawn and/or cancelled.
